

## PRIVACY AND COOKIE POLICY

### 1. Cookie Lighting Text

Kahveci Otomotiv San. Ve Tic. Aş. we use technologies such as cookies, pixels, gifs ("cookies") to improve your experience during your visits to our online channels (called "Company"). The use of these technologies is carried out in accordance with the legislation we are subject to, especially the Personal Data Protection Law No. 6698.

The purpose of this Privacy and Cookie Policy (as policy) informs you about the processing of personal data obtained by site visitors (you as data subjects) using cookies during the operation of the website operated by us. In this policy, we explain to you what kind of cookies we use on our site and how you can control them. When you continue to use the content, services and products offered on our site, you agree to all the principles declared in this policy.

### 2. Types and Purposes of Cookies That Our Site Has

Session Cookies :Means temporary cookies that are kept on your devices until you leave the website.

Functional and Analytical Cookies: It is used for purposes such as remembering your preferences, using the website effectively, optimizing the site to respond to user requests and includes data about how visitors use the site. Due to its nature, such cookies may contain your personal information. For example, cookies that record your language preference on our site are functional cookies.

Performance and Analytics Cookies: These cookies do not collect personally identifiable information and are deleted after the browser is closed. Thanks to Performance and Analysis Cookies, our use of our Site and the performance of our Site allows us to improve the services we provide to you.

### 3. Sharing with Third Parties

All personal information collected within the scope of the services of the Site will not be used

in any way other than the principles and purposes set forth in the privacy and cookie policy. Personal information collected will not be shared with third parties unless the user has a clear permission.

However, an official request from various judicial and administrative institutions of the Republic of Turkey, this personal information collected in accordance with the notification, request in accordance with the privacy and cookie policy, can be shared with the judicial and administrative institutions / institutions that make the notification.

#### **4. For What Purposes Are Cookies Used?**
