

## **LIGHTING TEXT FOR CAMERA RECORDS UNDER THE LAW ON THE PROTECTION OF PERSONAL DATA**

This Lighting Text; Kahveci Otomotiv San. Ve Tic. Aş. (Kahveci Otomotiv or Data Controller) under section 10 of the Personal Data Protection Law No. 6698. in accordance with article 2011, to fulfill the lighting obligation of the data controller, it has been prepared in accordance with the Communiqué on the Procedures and Principles to be followed in the Fulfillment of the Enlightenment Obligation. Kahveci Otomotiv; it shows the utmost sensitivity to the processing of your personal data in accordance with the relevant legislation and basic principles in the field of protection of personal data and to ensure the security of your personal data by taking all necessary administrative and technical measures. Your personal data will be processed by Kahveci Otomotiv in accordance with the procedures and principles described below.

### ***1) And the Identity of the Data Controller***

Your personal data is "3. Org. San. Böl. 13 Sk. No:19 Selçuklu/KONYA" Kahveci Otomotiv San. Ve Tic. Aş. is processed by the data controller.

### ***2) Purposes for Processing Your Personal Data***

Your personal and rights; ensuring physical space security, ensuring the safety of moved goods and resources, informing authorized persons, institutions, and organizations, creating, and tracking visitor records are limited. Your personal data will not be processed for different purposes other than for the purposes for which it is mentioned and will not be used for these purposes.

### ***3) To Whom and for What Purposes Your Personal Data May Be Transferred***

Your personal data: By Kahveci Otomotiv, limited to the purposes of carrying out activities in accordance with the legislation and informing authorized persons, institutions, and organizations, if requested, it may be transferred to the competent authorities and will not be shared with any person or organization other than this.

### ***4) Method and Legal Reason for The Collecting of Your Personal Data***

Your personal data: "the mandatory processing of data for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the person concerned" is processed based on legal reasons. This operation carryout by automatic means through cameras that record images 24/7.

### ***5) Section 11 of the Personal Data Protection Law No. 6698. Your Rights Listed in the Article***

Provided that you are concerned with the application you can make in accordance with the Communiqué on the Procedures and Principles of Application to the Data Controller or in accordance with the application form at [www.kahveci.com.tr](http://www.kahveci.com.tr) and the Application Principles and Application Form to the Data Controller at the same address.

- i. If the person is learning if the data has been processed,
- ii. Requesting information about personal data if it has been processed,
- iii. To learn the purpose of processing personal data and whether they are used in accordance with their purpose,
- iv. To know the third parties to which personal data are transferred at home or abroad,
- v. Request correction of personal data in case of incomplete or incorrect processing and notification of the transaction made in this context to third parties to which the personal data are transferred,
- vi. Although it has been processed in accordance with the provisions of the KVKK and other relevant laws, requesting the deletion or destruction of personal data and requesting notification of the transaction made in this context to third parties to which the personal data are transferred, in case the reasons that require it to be processed disappear,
- vii. Objecting to the emergence of a result against the person himself by analyzing the processed data exclusively through automated systems,
- viii. You may use your rights to claim damages in the case of damages due to unlawful processing of personal data.

Your application to use your mentioned rights will be answered as soon as possible and within 30 days at the latest through the communication channels you have shared and preferred.
